## ACES SWIM CLUB Policies - Revised 8-20-18

**Privacy:** All data collected through online registration is for the sole use of Aces Swim Club, its coaches, meet directors and volunteer coordinators. Information collected shall not be used for marketing, sales and /or solicitations to any other organization or individuals that are not directly affiliated with the Aces Swim Club and without prior permission from the Aces Swim Club. Because of membership requirement, relevant information required by Colorado Swimming Inc and USA Swimming will be forwarded to Colorado Swimming Inc. and USA Swimming. A membership directory available to all members will NOT be published.

**Fee Structure:** Aces Swim Club charges fees for Annual Membership (\$150.00), USA Swimming (\$72.00), practice groups and meet entries. Practice group fees are as follows:

Members are charged full monthly fee regardless of number of practices attended.

Meet entry fees vary from meet to meet and number of events swum.

**Refunds:** Family membership fees and USA Swimming fees and monthly dues are non-refundable. In instances in which swimmers do not swim in a particular month, monthly dues are waived. However, if automated monthly billing is selected, notice must be given to Aces Swim Club, in writing (to address below) or via email to: <a href="mailto:Barbiel@acesswimclub.com">Barbiel@acesswimclub.com</a> by the last day of the month prior to which your swimmer intends not to swim. For example, if your swimmer is not swimming in December, proper notice must be given by Nov. 30. Keep in mind that the Aces Swim Club bills its members at the beginning of each month. Automated billing transactions will occur between the 3<sup>rd</sup> and 10<sup>th</sup> of each month. Failure to notify the ACES by the last day of the month prior, in cases of automated billing, will result in monthly dues charges and are non-refundable. Members may terminate monthly billing, but notice must be given by last day of the prior month, or charges for that month will occur.

Swim meet registration fees are non-refundable.

**Length of Season:** The Aces Swim Club operates from September-August of each season. In general, there are no monthly dues in the month of August, however, Individual members may be charged in August if they are participating in practices

during the month of August. New and returning members are required to register and pay appropriate fees beginning each September.
